

- Grade 12 U-level Chemistry or equivalent (Nuclear Medicine & Molecular Imaging Technology applicants only)

A minimum cumulative Grade Point Average (cGPA) of B-

Biology, Mathematics, Physics and Social Science prerequisite courses must be part of (or transferable to) an undergraduate degree program; we do not consider diploma or certificate program courses for admission purposes.

Academically competitive applicants will be invited to participate in a mandatory admissions interview, and admission decisions are based on both the review of academic transcripts and interview scores.
